We all want to finish our lives well, leaving our families with fond memories and with all our affairs in order. Failure to prepare can leave our families in chaos, and can cause unnecessary stress, pain and resentment.

"Finishing Life's Journey Well" is designed to help you and your loved ones be prepared. We have assembled a panel of experts in the various issues surrounding death.

This workshop is designed for people over 60 to assist in their own thinking and planning, for the special loved one who will assist the person over 60 in planning, as well as for Church leaders (pastors, deacons) as they guide church members and their families through end-of-life issues.

Directions to New Creation Healing Center:

From the South: Take Interstate 495 North to Exit 51B towards Plaistow, NH. Travel approximately 7 miles on Route 125 into Kingston, NH. Stay on Route 125, you will pass Landscapers Depot on the right. Go through the next set of lights and we are just ahead on the left.

From the North: Take Route 101 to Exit 7 (towards Epping/Kingston). Proceed south on Route 125 South approximately 11 miles into Kingston, NH.

 - *What is a MOLST form? What is a POLST form? What is the difference?
 - *What emotional issues will my loved ones and I face as I near death and what should we do about them?
 - *How do I get my financial affairs in order so as to bless those who inherit from me and not cause family problems or lose money to the state?
 - *How should I plan my wake (calling hours) and funeral?
 - *How do I make that list of people who should be called upon my death?
 - *What should my obituary include?
 - *What are the advantages and disadvantages of burial versus cremation?
 - *How can I prepare spiritually for death? Is there a heaven and how does one get there after death?
 - *How do I make decisions about Social Security?
